**b. SPECIAL EVENT LIQUOR LICENSE - RACEWAY ELKS FOR FOURTH OF JULY DINNER DANCE FUNDRAISER**

City Council will consider a request for a special event liquor license from Mr. Gary Bruce on behalf of the Raceway Elks #2852 for a Fourth of July Dinner-Dance Fundraiser event to be held on July 3, 2010 at the Masonic Temple located at 1015 North 8th Street in Avondale. The Council will take appropriate action.

**c. AVONDALE TRANSIT CENTER STUDY ACCEPTANCE**

City Council will consider a request to accept the study conducted by the Maricopa Association of Governments on behalf of the City of Avondale to develop a template for a possible Transit Center facility within the Avondale City Center. The Council will take appropriate action.

**d. CONTRIBUTIONS ASSISTANCE PROGRAM - COUNCIL SUBCOMMITTEE RECOMMENDATIONS**

City Council will consider funding recommendations made by the Council Subcommittee for distribution of the proposed \$50,000 Contributions Assistance Fund. City Council will take appropriate action.

**e. THIRD AMENDMENT TO SERVICE AND SUPPORT AGREEMENT - KINSEY AND KINSEY**

City Council will consider a request to approve the third amendment to the Service and Support Agreement with Kinsey and Kinsey in the amount of \$21,355.62 for work performed on the Lawson benefits and payroll applications, approve a transfer from the Contingency fund, and authorize the Mayor or City Manager and City Clerk to execute the appropriate documents. The Council will take appropriate action.

**f. PROFESSIONAL SERVICES AGREEMENT - TECHNISOURCE FOR TRAINING AND TECHNICAL ASSISTANCE ON LAWSON PAYROLL SYSTEM**

City Council will consider a request to ratify a Professional Services Agreement with Technisource to provide training and assistance to the payroll staff for the Lawson payroll system in the amount of \$57,000, authorize the transfer of contingency funds and authorize the Mayor or City Manager and City Clerk to execute the necessary documents. The Council will take appropriate action.

**g. PURCHASE AGREEMENT - SIDE PATH FOR DISK SPACE FOR WATER RESOURCES SECURITY CAMERAS**

City Council will consider a request to award a purchase agreement to SidePath for additional disk space for Water Resources security cameras in the amount of \$61,425.00 and authorize the Mayor or City Manager and City Clerk to execute the necessary documents. The Council will take appropriate action.

**h. RESOLUTION 2921-610 - ARIZONA DEPARTMENT OF PUBLIC SAFETY VICTIMS OF CRIME ACT GRANT FY 2010-2011**

City Council will consider a resolution authorizing the acceptance of the Arizona Department of Public Safety Victims of Crime Act Grant award in the amount of \$44,399 with a City match requirement of \$11,100 and authorize the Mayor or City Manager and City Clerk to execute the necessary documents. The Council will take appropriate action.

**i. RESOLUTION 2920-610 - INTERGOVERNMENTAL AGREEMENT WITH WITH THE CITY OF TOLLESON FOR TRAFFIC SIGNAL AND STREETLIGHT MAINTENANCE AND REPAIR**

City Council will consider a resolution authorizing an Intergovernmental Agreement (IGA) between the City of Avondale and the City of Tolleson for traffic signal and streetlight maintenance and authorize the Mayor and City Clerk to execute the necessary documents. The Council will take appropriate action.

**j. ORDINANCE 1418-410 - AMENDING THE AVONDALE CITY CHARTER TO CHANGE THE ELECTION CYCLE AND REFER SUCH AMENDMENT TO THE QUALIFIED ELECTORS**

City Council will consider an ordinance amending the Avondale City Charter to change the election cycle and referring such amendments to to the qualified electors of the City of Avondale for consideration at the General Election to be held November 2, 2010. The Council will take appropriate action.

**k. ORDINANCE 1419-610 - AMENDMENT TO CHAPTER 13, ARTICLE IV OF THE AVONDALE MUNICIPAL CODE - ALCOHOLIC BEVERAGE LICENSES**

City Council will consider an ordinance amending Chapter 13, Article IV, Alcoholic Beverage Licenses, of the Avondale Municipal Code to update the language, remove the Application, Issuance and Annual Fees and directing them to be included in the Fee Schedule adopted annually by the Council. The Council will take appropriate action.

**l. ORDINANCE 1417-610 - DEDICATION OF EASEMENT TO SRP FOR THE AVONDALE BOULEVARD AND ENCANTO BOULEVARD IMPROVEMENT PROJECT**

City Council will consider an ordinance dedicating an Underground Power Distribution Easement to Salt River Project for the Avondale Boulevard and Encanto Boulevard Improvement Project and authorize the Mayor or City Manager, and City Clerk to execute the necessary documents. The Council will take appropriate action.

**4 CONSTRUCTION CONTRACT AWARD - CS CONSTRUCTION – AVONDALE BOULEVARD TRAFFIC INTERCHANGE IMPROVEMENT PROJECT**

City Council will consider a request to award a construction contract to CS Construction Inc. to provide construction services for the Avondale Boulevard Traffic Interchange Improvement Project in the amount of \$4,162,132.97 and authorize the Mayor, or City Manager and City Clerk to execute the necessary documents. The Council will take appropriate action.

**5 PURCHASE AGREEMENT - ROBERT COHEN COMPANY, LLC FOR THE PURCHASE OF BASKETBALL/VOLLEYBALL COURT FLOORING SYSTEM**

City Council will consider a request to approve a purchase agreement with Robert Cohen Company, LLC to furnish and install the basketball court flooring system for the American Sports Center in the amount of \$322,418.53 and authorize the Mayor or the City Manager and City Clerk to execute the necessary contract documents. The Council will take appropriate action.
