

[b\) PURCHASE CONTRACT – MATERIALS – VAN BUREN STREET & FAIRWAY DRIVE TRAFFIC SIGNAL](#)

City Staff is requesting Council award a materials purchase contract to Valmont Industries to pre-purchase traffic signal poles and appurtenances in advance of the installation of traffic signals at the intersection of Van Buren Street and Fairway Drive in the amount of \$67,777. The Council will take appropriate action.

**c) COMMUNITY DEVELOPMENT ADVISORY COMMITTEE APPOINTMENTS**

The Council will consider the reappointment of Council Member Raymond Shuey to another one year term as Avondale's representative on the Maricopa County Community Development Advisory Committee and the reappointment of Vice Mayor Betty Lynch as the alternate. The Council will take appropriate action.

**d) CHANGE ORDER 1 – STANDARD CONSTRUCTION CO. – 107<sup>TH</sup> AVENUE IMPROVEMENTS – DURANGO TO APACHE STREETS**

City Staff is requesting Council approval of Change Order 1 to the construction contract with Standard Construction Company, Inc. for the 107<sup>th</sup> Avenue Improvement Project between Durango and Apache Streets in the amount of \$83,616.92. The Council will take appropriate action.

**e) CONTRACT AMENDMENT FY 2004-2005 AREA AGENCY ON AGING**

City Staff is requesting Council approval of an amendment to the FY 2004-2005 Area Agency on Aging contract in the amount of \$5,700 to purchase computers for use by seniors in the Avondale and Cashion Community Centers. The Council will take appropriate action.

**f) CHANGE ORDER 2 – HUNTER CONTRACTING COMPANY, INC. – 107<sup>TH</sup> AVENUE AND THOMAS ROAD IMPROVEMENT PROJECT**

City Staff is requesting Council approval of Change Order 2 to the construction contract with Hunter Contracting Company, Inc. for the 107<sup>th</sup> Avenue and Thomas Road street improvement project in the amount of \$39,510.43. The Council will take appropriate action.

**g) UNIFORM SERVICES CONTRACT AWARD – G & K SERVICES**

City Staff is requesting Council approval of a unit price contract with G & K Services to provide employee uniform services. The Council will take appropriate action.

**h) MAP OF DEDICATION – PLAZA CIRCLE DRIVE**

The Council will consider a request from Tom Hill, Sun Cor Development for approval of a map of dedication for Plaza Circle Drive from a point 187 feet east of 137<sup>th</sup> Avenue to Osborn Road. The Council will take appropriate action.

**i) CONSTRUCTION MANAGER AT RISK PRE-CONSTRUCTION SERVICES AGREEMENT – PCL CIVIL CONSTRUCTORS, INC. – WELLHEAD TREATMENT FOR ARSENIC REMOVAL PROJECT**

City Staff is requesting that the Council award a Construction Manager at Risk Pre-Construction Services agreement to PCL Civil Constructors, Inc. for the Wellhead Treatment for Arsenic Removal Project at the Northside Water Facility in an amount not to exceed \$1,465,102. The Council will take appropriate action.

**j) AMENDMENT 2 – PROFESSIONAL SERVICES CONTRACT – KIRKHAM MICHAEL CONSULTING ENGINEERS**

City Staff is requesting Council approval of Amendment 2 to the Professional Services contract with Kirkham Michael Consulting Engineers in the amount of \$6,684 for additional design services for a traffic signal at the intersection of Van Buren Street and Fairway Drive. The Council will take appropriate action.

**k) ORDINANCE – RIGHT-OF-WAY – SOUTH AVONDALE SIDEWALK PROJECT PHASE 2**

The Council will consider an ordinance accepting the dedication of certain right-of-way related to the South Avondale Sidewalk Project, Phase II. The Council will take appropriate action.
